On Monday, May 12th, 2008 police were called to the CBC building located at 25 John Street for a Threatening.

An unknown male was observed on security camera to approach the building from the north along Wellington Street West, continue westbound to the corner of the building where he turned southbound and entered the main door at 25 John Street. The suspect was caught on camera videotaping the building while he approached the main door.

Once inside the suspect approached the security desk which was manned by officer Fernado SERRANO ORDUNA. The suspect approached the officer and stated, "Do you know the number for 911?" The officer, in an attempt to clarify, asked why and the male responded, "because I am going to kill everyone in the CBC!" Another employee of the building approached the scene and the suspect stated, "Too late!". The officer again asked "why" as the female employee Shelagh O'Donnell stood at

the desk. The suspect repeated the threat a second time with more conviction. "I am going to kill everyone in CBC!".

The suspect then slowly backed away from the desk and took a photo of both witnesses with a metallic red 'SONY' digital camera phone. The suspect asked the guard, "Do you know who I am ?", "Do you remember me?", which made the officer think he may be a disgruntled employee. The officer said that he did not recognize him.

As the suspect left he said to both witnesses" I have your picture". "And yours too" (to O'Donnell).

The suspect then left out the same door from which he entered and immediately crossed the street where he continued to take photographs and shake his fist toward the building.

The suspect was last seen walking northbound toward Wellington Street West.

Typewritten statements were turned over to police as well as surveillance video capturing the suspect while he was on CBC property.



Security Occurrence Report - Monday, May 12th, 2008

Incident #1

At 1327 hours a male individual entered the Toronto Broadcasting Centre via the John St. Doors and proceeded to the John St. Access Control Desk. The Desk Officer at the time was Fernando Serrano. The unidentified male approached the counter and said, "You know to call 911, because I am going to kill everybody at the CBC." Security Officer Serrano asked the male to repeat himself. The male then stated, "You know who I am, you know." CBC employee Shelagh O'Donnell had arrived at the desk within in seconds of the male's arrival and had also heard the male's threats. The male then turned and walked towards the John St. exit doors. The male then stopped and turned around and took what appeared to be photos of the Officer and a CBC employee who had witnessed the incident at the desk. The male was then observed exiting the building and crossing John St. He was seen waving his hands in the air and soon walked north on John St. towards Wellington St. and out of sight. Officer Serrano and Ms. O'Donnell both then immediately wrote down a description of the individual. At 1329 hours S/O Serrano then notified Security Supervisor, Marcus Ritchie of occurrence. Security Supervisor, Marcus Ritchie took the description and immediately went out the John St. Doors to search the surrounding area. S/S Ritchie searched from John St. to Wellington St. and from Wellington St. to the Simcoe Laneway. S/S Ritchie did not observe any one matching the description and returned to the building at 1335 hours. S/S Ritchie then began reviewing CCTV footage to confirm occurrence and description of the male. At 1342 hours, S/S Ritchie advised Security Manager, Brian Courchesne of the incident. S/S Ritchie commenced burning footage and Security Manager, Brian Courchesne contacted CBC employee, Shelagh O'Donnell and spoke with her regarding the incident. Ms. O'Donnell explained her observations in detail and confirmed exactly what S/O Serrano had reported earlier. At 1353 hours, the Security Manager then called Toronto Police communications and requested an Officer to attend the site as soon as possible. The Males description was given to the Police Communications at that time. At 1404 hours, Assistant Facility Manager Brendan Murphy was advised of the incident and that the Police had been contacted to file a report. Security Manager, Brian Courchesne then contacted Shelagh O'Donnell again and requested a written statement from her via email and asked her if she would not mind providing an eye witness account when the Police Officer arrives. Shelagh O'Donnell confirmed that she would be happy to provide the information on what she had observed and further speak with the Police upon their arrival on site. At 1436 hours, Toronto Police Officer, SGT. Jason Tomlinson arrived on site, was briefed by Security Manager Brian Courchesne on the incident and commenced interviewing S/O Serrano. At 1438 hours, Shelagh O'Donnell sent her e-mail statement and was contacted to come down to Security Administration and provide the verbal account to the attending Police Officer. At 1445 hours Shelagh O'Donnell arrived in Security Administration to give her statement. At 1505 hours, Zissis Liolios of CBC Real Estate asked for recommendations regarding extra Security Patrol Coverage. Security Manager, Brian Courchesne recommended one extra patrol Officer to commence at 1600 hrs. Zissis Liolios approved the costs for the extra manpower for Security Patrols. At 1518 hours a detailed HIGH ALERT was sent out to all Officers to be on the look out for the Male in question. A detailed description of the Male Subject was included in the High Alert memo. Instructions of what the Security Officers were to do if the Male Subject was observed on the property were also given in the High Alert memo. Arrangements were made to have an extra Officer assigned to patrol the ground floor interior and exterior. Securitas Client Service Manager, Mike Bezoff briefed and was asked to provide some Mobile Patrols of the perimeter of the building. At 1545 hours, the Police Officer finished taking the report and statements. CCTV footage of the incident and the Male in question were turned over to SGT. Tomlinson. Before leaving SGT. Tomlinson advised that he would take a drive around the area to see if the male in question could be found. At 1559 hours. Both Security Officer Sarrano's report and Shelagh O'Donnell's Statement were sent to all required parties along with a brief status report of what had transpired thus far. END

Officer Adeleke notified Security Control that he believed that he had observed the Male subject in question. Security Supervisor, Alan Ward-Close and Patrol Officer David Mathura. S/S Ward-Close was dispatched and stopped the subject in the John St. Corridor and requested identification from the male subject. He produced it willingly but quickly asked for it back. S/S Ward-Close originally reported the name of a Michael O'Keefe. (The accused actual name is Stephen O'Keefe. Due to the situation that transpired it is likely that in the heat of the moment S/S Ward-Close mistakenly remembered the common name of Michael instead of Stephen) S/S Ward-Close asked the subject to accompany him to the Security Office. The male subject agreed and seemed to be going peacefully. When they arrived at the Security Office entrance he refused to enter and became very agitated. He then broke for the door and exited out on to John St. S/S Ward-Close gave chase. The male escaped running north on John St. and West on Wellington St. S/S Ward-Close returned to the office and contacted the writer, Security Manager, Brian Courchesne on his cell phone. S/S Ward-Close was advised to call the Police immediately and to file another report with them. Further S/S Ward-Close was asked to complete a detailed Security Report. At 2157 hours the writer, Brian Courchesne then called Assistant Facility Manager, Brendan Murphy on his cell and advised him of the Occurrence by leaving a voice mail. The writer then called Facility Manager, Andrew Byerlay and spoke directly to him advising of the situation. At 2228 hours Toronto Police arrived on site. Officer I indale #1901 and Pasquino # 4970 were briefed by S/S Ward-Close on the history as stated above in Incident #1. A photo was provided of the subject in question. CCTV Footage was going to be provided to them the following day. Officers instructed S/S Ward-Close to arrest the subject for trespassing should he arrive on site again and call 911. The officers were off site at 2257 hours.

Security Occurrence Report - Tuesday, May 13th, 2008

Incident #3

At 1244 hours, the writer Security Manager, Brian Courchesne received a phone call from Security Supervisor, Marcus Ritchie advising that the subject male was spotted in the building and that he was on his way to John St. The writer ran to the John St desk and observed the subject standing there. S/O William Cozier advised the writer that he believed that this was the fellow the CBC Security Team was on High Alert for. At 1245 hours, the writer asked him if he was O'Keefe? He said yes, well, right now I am. The accused then tried to take a picture of the writer. S/O Boureima Ousman grabbed the camera from him. The writer told the accused that he would have to come with him. The accused made a brief attempt to walk towards the John St. exit. The writer took physical control of the accused arms, and brought him into the Security Supervisor's office. At this point the accused was notified of his arrest for trespassing. His was given his rights to counsel and advised that the Police were on their way. At approximately 1247 hours, Toronto Police Services were notified that the accused was being held for trespassing because he had uttered death threats on the previous day. Zissis Liolios, CBC, and Brendan Murphy, Profac (Building Management) were then notified of the situation. At 1310 hours, two Toronto Police Officers arrived on site Badge # 5013 and # 5309. The writer quickly briefed them on the two previous incidents and the uttering of the death threat on the previous day. The writer further advised that he wished to pursue with the death threat charges. The accused was identified as Stephen O'Keefe, DOB 1968 - Jul - 5. The Officer searched the accused and placed handcuffs on him. The camera that the accused was in possession of upon being arrested was turned over to the attending Officers. The accused was then taken to away to 52 Division for processing. Detective Constable, David Dickinson and Detective Brown will be the contact points on this incident Moving forward. End




